



**BarkPark Dubai Dog Day Care Service Contract**

I \_\_\_\_\_ agree to the following for my dog's care at BarkPark Dubai:

1. **Vaccinations:** I confirm that my dog is current with the following vaccinations: Rabies, DHPPL (first vaccinations including boosters must have been completed a minimum of 21 days prior to entry to BarkPark Dubai and annual boosters at least 72 hours prior to entry). I agree to provide evidence of this in the form of my dog's vaccination booklet. For Bordetella (Kennel Cough) we recommend, but do not insist, on this vaccination, however if it has been administered it must have been at least 14 days prior to entry. I understand that even with a current vaccinations there remains a chance that my dog could still contract any other contagious diseases. \_\_\_\_\_(Initials)
2. **Titer Test:** I confirm that my dog has undergone and passed a Vaccicheck Antibody Titer Test in the last 12 months prior to commencement of boarding and indicating that my dog has sufficient immune protection against Canine Parvovirus, Canine Distemper virus, Infectious Hepatitis. I agree to provide evidence of this in the form of my validated test result from a licensed veterinarian. \_\_\_\_\_(Initials)
3. **Payment:** I accept that the full cost of day care and any other known fees (eg transportation services) are payable at the time of check in. I undertake to make full payment for additional costs eg extended stay, vet fees, additional food, damage etc at the time of collection. \_\_\_\_\_(Initials)
4. **Spay/neutering** I note that BarkPark Dubai's preference is that all dogs aged 12 months & above be spayed/neutered before coming to BarkPark Dubai and that BarkPark Dubai has the right to refuse day care to any unneutered male or female dog. If my dog is female and is not spayed I understand I MUST tell BarkPark Dubai when her season is expected, (day care will be refused of any unneutered female whose season is expected). Should my female dog have an unexpected pregnancy I accept full liability and accept that BarkPark Dubai will not be held responsible in any way. \_\_\_\_\_(Initials)
5. **Parasite Treatment** all dogs must be treated for external parasites prior to arrival. Should this not have occurred I authorise BarkPark Dubai to apply Frontline (or similar) topical treatment at the time of arrival. The cost of this treatment is AED 130 which I am responsible for or I can provide my own and BarkPark Dubai staff will apply upon arrival free of charge. Should a parasite be found on your dog whilst with us please note we will immediately isolate your dog and then inform you of our finding. You must come to collect your dog personally and as quickly as possible. No refunds will be made for services cut short due to this reason. \_\_\_\_\_(Initials)
6. **Food & Medicines:** I understand that I am responsible for leaving an adequate supply of food and/or medications if required for my dog's stay. Should there be a need for any additional food/medicine I authorise BarkPark Dubai to purchase on my behalf and agree to reimburse any expenses incurred. \_\_\_\_\_(Initials)
7. **Emergency Vet Care** I authorise BarkPark Dubai to arrange any necessary emergency veterinary care and accept any and all costs associated with transportation and treatment of such. Should my preferred vet be unavailable I authorise BarkPark Dubai to engage the services of an alternative vet of their choice. If I cannot be reached in a timely manner I authorise BarkPark Dubai to approve medical / emergency care as recommended by a veterinarian and accept that the attending vets recommendation will be final. I will reimburse BarkPark Dubai for any and all expenses incurred. \_\_\_\_\_(Initials)
8. **Minor injuries or illness** In the event of a minor injury (eg an ear bite or small puncture wound) or illness (eg vomiting, diarrhoea) I agree for BarkPark Dubai to handle this before contacting me. BarkPark Dubai will make me aware of any medical conditions in a timely manner. I will reimburse BarkPark Dubai for any and all expenses incurred. \_\_\_\_\_(Initials)



- 9. **Damage** I accept that I am liable for any damage caused by my dog to its enclosure, bed or other property in BarkPark Dubai. I will pay reasonable costs for any damage caused. \_\_\_\_\_(Initials)
- 10. **Personal Belongings** I understand that I may leave my dogs bedding, toys, bowls etc for use with my dog(s) during their stay and whilst BarkPark Dubai will endeavour to take good care of any such personal items I will not hold them liable for any loss or damage that may occur to these items. \_\_\_\_\_(Initials)
- 11. **Failure to collect my dog:** Should I fail to collect my dog within 1 hour of the agreed departure time I accept that I will be charged at the rate of AED 25 per hour for each hour of overstay. In the event that I fail to collect my dog entirely I authorise BarkPark Dubai to remove my dog from their care by any method they deem appropriate. I understand and agree that I remain responsible for any outstanding costs relating to the care or removal of my dog. \_\_\_\_\_(Initials)
- 12. **Transportation:** BarkPark Dubai provides pet transportation services for dogs. BarkPark Dubai endeavours to transport all pets in a safe manner and will exercise reasonable care at all times. I understand that dogs can sometimes be injured or become ill during transportation and understand that every dog reacts differently and that animals, by nature, are unpredictable. I will not hold BarkPark Dubai liable financially or legally for any physical, mental or health issues that arise during or because of my dog’s transport provided by BarkPark Dubai. \_\_\_\_\_(Initials)
- 13. **Acknowledgement of risk and release:** I recognize that there are risks to myself and others and to my dog and the dog’s and property of others in a dog day care, boarding kennel and dog park environment. I further recognise that BarkPark Dubai allow dogs frequent access to their large outdoor area to play and exercise and, whilst such access is supervised, I accept the risks and dangers inherent within dog parks e.g. physical strain, dog fights, dog bites, dog escape over and under fences, exposure to burrs or seeds that may become lodged in the dog’s coat, feet, eyes, nose or ears, and mosquitoes, ticks, mites, fleas or other insects and wildlife that might be found in the UAE such as snakes, scorpions, spiders etc. I hereby release BarkPark Dubai, its officers, employees, agents and the landowner, from any and all responsibility or liability for injuries or damages to myself or my dog due to my dogs use of, or participation in activities at, BarkPark Dubai. I also agree to indemnify and save harmless BarkPark Dubai, its officers, employees, agents and the landowner from and against all loss, cost, damages, expense and liability including death, personal injury or disease and damage to real or personal property resulting from (1) my negligent acts; (2) the acts or behaviour of my dog, and (3) injury that may occur to me or my dog or my property as a result of the acts, conduct or behaviour of other users of BarkPark Dubai, including other dogs. \_\_\_\_\_(Initials)
