ACKNOWLEDGEMENT OF RISK AND RELEASE

BarkPark Dubai is a dog park i.e. an area that is fenced in and where dog owners may bring their dogs and permit them to run freely with other dogs. To make use of BarkPark Dubai, owners must complete a membership application or a registration form for entrance to BarkPark Dubai, present vaccination records, valid Titer Test certificate, personal ID and pay the appropriate fee. BarkPark Dubai makes no guarantee that all dogs or other animals present in BarkPark Dubai area are licensed or vaccinated against rabies and/or DHPPL, nor can it guarantee that children will not gain admission, or that children who are admitted will behave appropriately. Further, BarkPark Dubai has no knowledge about the behaviour or temperament of animals using the area. In consideration of receiving access to BarkPark Dubai for myself and the dog(s) identified in this form, I hereby represent and warrant as follows: my dog(s) _____ / _____ / _____ is/are licensed in the UAE and has received Rabies & DHPPL vaccinations & Titer Test, which are fully up to date. I understand that even with a current vaccinations there remains a chance that my dog could still contract any contagious diseases. I recognize that unleashing my dog and being present in an area where there are other people, including children, and other unleashed dogs poses risks to myself and others and to my dog and the dogs and property of others. For instance, there is the risk of personal injury or property damage to myself or others from aggressive dogs, the unpredictable behaviour of dogs and the lack of adequate training of my dog or other dogs. I further understand and accept that despite the efforts of BarkPark Dubai to see that users comply with licensing and vaccination requirements, there is a risk that not all dogs present in BarkPark Dubai are licensed and vaccinated. Additional risks to myself and others include, but are not limited to, dog fights, dog bites, dog theft or unlawful capture, dog escape over and under fences, and dog access to vegetation or standing water that may be unhealthy or poisonous if consumed. Further, dogs may be exposed to burrs or seeds that may become lodged in the dog’s coat, feet, eyes, nose or ears, and mosquitoes, ticks, mites, fleas or other insects and wildlife that might be found in the UAE such as snakes, scorpions, spiders etc. I understand that use of BarkPark Dubai is self-directed and not supervised by any agent or employee of BarkPark Dubai. I assume all risks associated with using BarkPark Dubai, including its fixtures and equipment, in an unsupervised and self-directed manner.

BarkPark Dubai reserves the right to use any photograph/video taken at any time within BarkPark Dubai, without the expressed written permission of those included within the photograph/video. BarkPark Dubai may use the photograph/video in publications or other media material produced, used or commissioned by BarkPark Dubai including but not limited to: social media, brochures, invitations, books, newspapers, magazines, television, etc.
